

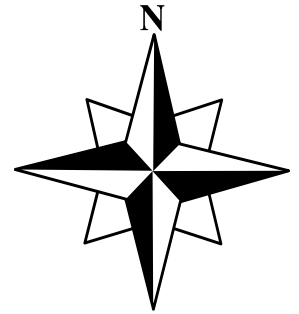

Grand Knight's Message

Last month in this column I highlighted the fact that due to the number of 50th Anniversary events that would be taking place this year, we might have to forgo one of our larger traditional charitable events to fit everything in. At this time I want to announce that after careful consideration by the council officers, it has been decided that we will not be having the Charity Ball this year. This decision did not come easily but the overwhelming success of the 2008 Charity Ball clearly demonstrated the commitment of this council and our community to the worthy causes we support and gives me great confidence that this wonderful event will not be hurt by a one year hiatus. Last spring, under the leadership of Tom O'Connell we established strong bonds to our local businesses that we will utilize once again in the spring of 2010. I realize that some members may view this decision as a deviation from our principle of Charity first, but let me assure you that this is not the case and that plans are in place to ensure that we continue to be a Christ centered, Charitable organization throughout our Golden Anniversary year.

To address this concern I have asked Deputy Grand Knight, Joe Kozelsky to take on a special role this year to facilitate the planning and execution of a number of smaller, clearly focused, charitable and community based activities. The idea is to have a number of

short duration projects that will allow our senior members to work with our new members to quickly get them involved. Joe's role is to help initiate and facilitate, not to run these special events. Please contact him directly if you have ideas for projects that fulfill these guidelines. He already has some projects in the works and is actively looking for more.

As an example of how this concept has already played out in our council, I want to highlight an event that Joe championed earlier this fall. In early September, Brother Knight, Deacon Mark Robbins approached Joe about the possibility of pulling together some Knights to do some much needed yard work for a housebound member of St Paul's parish who was currently in the hospital. After a few e-mails to Trinity Council members from St Paul's parish and myself as Grand Knight, Joe was able to solicit help from 6 members who volunteered to give up a Saturday morning to help with this task. Upon arrival at the worksite it was quickly apparent to all involved the importance of this project. With hedges higher than the eaves and the gutters growing a forest of seedlings, the reason for this project was instantly obvious. The ladders were unloaded, the chainsaws and hedge clippers fired up and the work begun. Working together under the leadership of Deacon Mark, we quickly attacked the task at hand and within three hours the job was done. In this short time we gave the home a facelift and once again restored this

So what did the Knight's get out of this you might ask? A sincere sense of pride in a job well done, a sense of unity in purpose and the satisfaction of knowing that even with only few men, the charitable work of our Order can be undertaken for those in need. 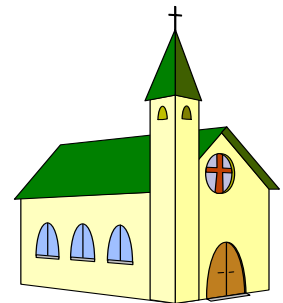

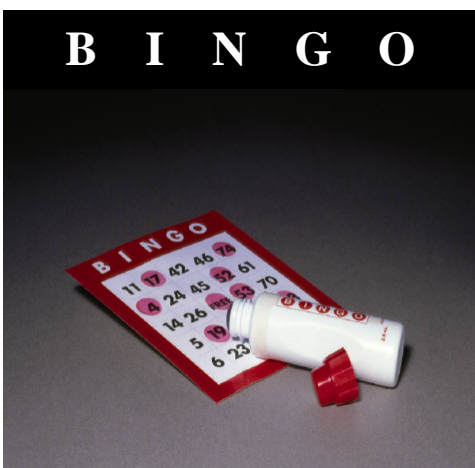

TO SEE THE POPE

“Ed, do you have any tickets to see the pope?” “No” came the answer. “I can’t even get to see him myself.” The inquisitor was Ray Pfeifer, Trinity Council Past Grand Knight, Past New York State Deputy, Past and current State Membership Director and Past Master, Fourth Degree. The respondent was Edward Castellazzi, current State Deputy. The place: a downstate gathering to plan a new financial secretary training program. The time: four days before Pope Benedict XVI’s April 11, 2008 arrival in New York City.

Disappointed, Ray returned home to Williamson. And then, a miracle. Two days later, the call came. Edward Cardinal Egan had just contacted the State Deputy to offer 35 tickets to His Holiness’ Saturday appearance at the United Nations, the centerpiece of his first United States visit as pope. Castellazzi, remembering his conversation with Ray, called to deal him in. Ray claimed two tickets for himself and his wife, Sara. Arthur (known in these parts as “Art”) Harris, Secretary to the State Deputy and fellow foot soldier in the brigade that is the New York State Council Knights of Columbus, received a similar invitation. So off the trio went, to a hotel in the Hud-

son Valley north of the City. On Saturday morning they were taken by limo to the U.N., or actually, a block away from the U.N. What followed will not soon be forgotten.

“We went through security with no problems,” Ray recounted. “We were then taken to a fourth level suite in the back of the General Assembly, usually occupied by U.N. personnel.

When the pope came on the stage we could see him pretty well. We and other occupants of the suites stood up started cheering. Eventually, the diplomats stood and applauded too. There were no prayers because technically the pope was appearing as a head of state, not a religious figure.”

The Pfeifers came away from their encounter with Pope Benedict impressed. “Being in his presence, there was an aura about

him,” marveled Ray. “He turned me on. It was as close as I can hope to come on earth to being in God’s presence. “Being in his presence, being close enough to see him, that’s what I’ll always remember,” echoed Sara.. Ray was also impressed that following his address to the General Assembly Pope Benedict took the time to hold a private meeting with children of United Nations workers.

The Pfeifers mentioned that they had also seen Pope John Paul II in person. Are there any readers who have seen three or more popes? A free drink at the WCC bar and suit-

ADDRESS OF HIS HOLINESS BENEDICT XVI TO THE BOARD OF DIRECTORS OF THE KNIGHTS OF COLUMBUS

Dear Friends,

I am pleased to welcome you, the Board of Directors of the Knights of Columbus, together with your families, on the occasion of your pilgrimage to Rome in this Pauline Year. I pray that your visit to the tombs of Saints Peter and Paul will confirm you in the faith of the Apostles and fill your hearts with gratitude for the gift of our redemption in Christ.

At the beginning of his Letter to the Romans, Saint Paul reminds his hearers that they are “called to holi-

ness” (Rom 1:7). During my recent [Pastoral Visit to the United States](#), I wished to encourage the lay faithful, above all, to recommit themselves to growth in holiness and active participation in the Church’s mission. 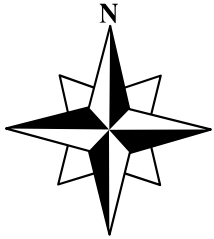
